**ORDER**

**Subject : Regarding functioning of Courts till 14.08.2020.**

Pursuant to order of Hon'ble High Court of Delhi bearing No. 26/DHC/2020 dated 30.07.2020, it is directed that all the Judicial Officer posted in North-West & North District, Rohini Courts, Delhi shall comply with the directions contained in the said orders in the following manner:-

1. All the Courts functioning in North-West District & North District, Rohini Court Complex shall henceforth take up all the cases listed before them through videoconferencing from 10:00 AM onward. However, evidence shall be recorded only in *ex-parte* and uncontested matters where the same is required to be tendered by way of affidavit. All the Judicial Officers are further requested to adhere the provisions of “**Video Conferencing Rules**” framed by Hon'ble High Court of Delhi in letter & spirit during the course of proceedings conducted through Video Conferencing.
2. The judicial officers posted in both the district i.e. in North & North-West District, Rohini Courts, Delhi shall be permitted to come to court for holding video-conference hearings from their respective chambers only when they do not have requisite technical infrastructure at their residences or where there is a breakdown of such infrastructure. Since, the present system of virtual courts has started just now, therefore, all the Judicial Officers are requested to not to pass any adverse order in absence of a party, so far as possible.
3. Physical hearings shall be permitted in those matters only where a grave urgency is involved and hearing through videoconferencing is not feasible.
4. For pronouncement of judgment in a criminal case, wherever required, the judicial officer may come to court for the same. In all such instances of physical hearings, the norm of social distancing be scrupulously adhered to.

Further, In order to facilitate the appearance of the Advocates in their respective matters, a list containing names of the Reader of each court alongwith their mobile number, e-mail-ID and meeting URL of CISCO software of each court of both the district of Rohini Courts, Delhi is attached herewith as *Annexure 'A' & 'B'* for North-West and North District respectively. The Advocates/parties may join the proceedings through the given meeting URL which does not require any meeting ID or password.

The Judicial officers and Branch In-Charges of both the district are directed to call upto 60% of the staff members of their respective Court and Branch and they shall prepare a roster to that effect and send to the undersigned(s).


